

CBI presents a new universe for AlphaVerse: Qtopia, the first metaverse dedicated to the LGBTQ community

- Universe developed in partnership with community representatives
- Priority given to the creation of a virtual world allowing members to meet around important topics related to the community

CRYPTO BLOCKCHAIN INDUSTRIES (CBI, Euronext Growth Paris: FR0014007LWO, ALCBI) announces the creation of Qtopia, the first metaverse dedicated to the LGBTQ community. Owned and developed by CBI, Qtopia will provide, from its launch in early 2023, an online space promoting LGBTQ culture and advocacy within AlphaVerse, CBI's metaverse.

In partnership with Rachel Kimelman and Jordan Weiss, co-founders of the LGBTQ social app Qutie, Qtopia is set to be an online venue for members of the LGBTQ community and their allies to meet and share. This universe will allow the LGBTQ community to interact and exchange ideas in a supportive universe, and coordinate initiatives both within and beyond the virtual world. Users will be able to create a fully immersive experience including houses, apartments and other virtual meeting places. Part of the proceeds from the sale of select properties will also be donated to LGBTQ charities. The launch of Qtopia will be supported by partners including the Stonewall Inn Gives Back Initiative, Ali Forney Center, Hudson Pride Center, Princess Janae Place, Open Finance, Playout Apparel and Stuzo Clothing. The Qtopia team is also working with celebrity DJ, TV host and advocate Joshua Zeke Thomas, son of famed NBA star Isiah Thomas, who is committed to his fans and will provide a unique experience in the virtual world

"We are very enthusiastic and proud to announce the first LGBTQ-focused Metaverse and to partner with AlphaVerse to launch it", stated Jordan Weiss and Rachel Kimelman who are joining CBI as consultants." Qtopia will support the community by not only providing a space to meet virtually from around the world, but also financially, as a portion of sales will be donated to charity and our universe will focus on supporting LGBTQ-friendly projects".
